BYLAW #1-02 A BYLAW OF THE TOWN OF PORCUPINE PLAIN TO CLASSIFY, LICENSE, REGULATE AND GOVERN BUSINESSES

The council of the Town of Porcupine Plain in the Province of Saskatchewan enacts as follows:

- 1. In this bylaw the expression "transient trader" shall have the meaning ascribed to it by the Urban Municipality Act 1984.
- 2. No person shall carry on any of the businesses set out in section 9 of this bylaw within the town unless he possess a valid and subsisting license for the purpose issued in accordance with the provisions of this bylaw.
- 3. The secretary treasurer of the town is hereby authorized to issue a license to any person carrying on business in the town;
- (a) who is not assessable by the town for the purpose of business taxation in respect of that business; and
- (b) who makes application for such license stating specifically the nature of his business in the town; and
- (c) who has complied with The Auctioneer's Act if the same applies or may apply in respect of the license for which he has made application under this bylaw; and
- (d) who tenders with his application the proper license fee as herein provided for.
- 4. Subject to the right of the council to suspend or revoke the same, as provided by the Urban Municipality Act 1984, every license issued hereunder shall remain in force and effect until and including the thirty -first day of December of the year of issue.
- 5. Where a license is issued hereunder after September 1st of any year the fee payable under section 9 shall be reduced by 50 per cent.
- 6. Every license issued hereunder shall specifically state the kinds of services, goods and merchandise which the license is authorized to offer for sale or take orders for as the case maybe and whether in the case of goods or merchandise, he may offer the same for sale by retail or by public auction or both. Such license shall also state the restriction as set forth in section 7 hereof.
- 7. No person to whom a license has been granted under this bylaw shall offer for sale services, goods and merchandise or solicit orders for future delivery of goods or merchandise within the town;
- (a) other than the kind or kinds described in license; or
- (b) by any method except as authorized therein; or
- (c) at any time or during any period when shops within the town offering for sale or taking orders for similar services, goods and merchandise are required by town bylaw to be and remain closed.
- 8. Every person licensed under this bylaw shall, at all reasonable times upon request of the secretary treasurer, the town constable or license inspector, or any peace officer, produce such license for inspection purposes.
- 9. Subject to section 5, the fee payable for a license under this bylaw shall be as set for in Appendix "A" attached to and forming part of this bylaw:

10. Bylaw #6-99 is hereby repealed.


